An eligible employee working for a covered employer can access paid leave under the Families First Coronavirus Response Act by checking with their employer, requesting the leave, and letting their employer know which of the qualifying conditions applies. To be eligible to enroll in health coverage through the Marketplace, you: Must live in the United States. Must be a U.S. citizen or national (or be lawfully present). Learn about eligible immigration statuses. Can't be incarcerated. If you have Medicare coverage, you're not eligible to use the Marketplace to buy a health or dental plan.

SNAP eligibility has never been extended to undocumented non-citizens. Specific requirements for non-citizens who may be eligible have changed substantially over the years and become more complicated in certain areas. The Food and Nutrition Act of 2008 limits eligibility for SNAP benefits to U.S. citizens and certain lawfully present non-citizens.

Program-Based Eligibility for Free Government Smartphones & Cell Phones. The vast majority of applicants for free government phones apply through this option. The basic rule for this eligibility alternative lies in the principle that if you are currently enrolled in at least one of government-assisted programs, then you automatically qualify for a free phone from the government.

Medicaid is a joint federal and state program that, together with the Children's Health Insurance Program (CHIP), provides health coverage to over 72.5 million Americans, including children, pregnant women, parents, seniors, and individuals with disabilities. Medicaid is the single largest source of health coverage in the United States.

Q: Am I eligible for benefits during a leave of absence from my job? A: To be eligible for unemployment insurance, you must be ready, willing and able to work, and actively looking for work. You must be ready to start work at once and be physically and mentally capable of working to receive benefits.

Part-time. Part-time employees may be eligible for Paid Family Leave. Part-time employees who work a regular schedule of less than 20 hours per week for a covered employer are eligible to take Paid Family Leave after working 175 days for their employer, which do not need to be consecutive, unless they qualify for and have executed a waiver.
