The NFPA committee clarified for the 2010 edition that the former interpretation is correct. This means that in a building with a 30 ft (9 m) riser, the hydrostatic test is conducted with 200 psi (1.4 MPa) at the base of the riser and the pressure will only be 187 psi (1.29 MPa) at the piping at the top of the riser.

NFPA 10(10), Section 7.2.4 requires that records be kept of all extinguishers inspected, including those needing corrective action.

### MAINTENANCE AND TESTING OF PORTABLE FIRE EXTINGUISHERS

I would say yes the records are to show at least the last 12 monthly inspections in accordance with Section 7.2.4.5 of the 2010 NFPA 10. This means to me if records are kept on a tag attached to the fire extinguisher, the tags from the previous year must be kept on file or on the fire extinguisher to comply with Section 7.2.4.4.
