Property Disclosure Statements (By State) Required in most States that details the condition of the property. In most States, the seller is required to report any structural or material defects in the property (e.g. leaking roof, flooding, etc.). Depending on the State, the seller may be held liable to any statements or claims made or not made.

As the seller of residential real property, you are required by law to complete and sign a Property Condition Disclosure Statement as prescribed by Real Property Law § 462(2) and cause it, or a copy thereof, to be delivered to a buyer or buyer's agent prior to the signing by the buyer of a binding contract of sale.

The Seller Property Disclosure Form in NY Explained ...

The Uniform Property Condition Disclosure Act (Connecticut General Statutes Section 20-327b) requires the seller of residential property to provide this disclosure to the prospective purchaser prior to the prospective purchaser's execution of any binder, contract to purchase, option or lease containing a purchase option.
